Amendment to the Hong Kong Offering Document

The following amendment will be made to the Hong Kong Offering Document of the Fund with effect from 26 May 2008. This amendment will form part of the Hong Kong Offering Document of the Fund which should be read as amended by this amendment.

The 3rd paragraph in the sub-section headed "*In-kind Creation and Redemption*", which is under the section headed "Purchase and Sale of Units on SEHK and Creation and Redemption of Units", on page 13 of the Hong Kong Offering Document of the Fund will be deleted in its entirety and replaced by the following:

"The cut-off time (**Dealing Deadline**) for making an in-kind creation application and an in-kind redemption application is 15 minutes after the official closing time of the SEHK on each Dealing Day, or such other time prior to the calculation of the Net Asset Value of the H-Share ETF on that Dealing Day as the Manager may determine and agree with the Trustee. The current Dealing Deadline is 4:25 p.m. (Hong Kong time) if it is a full trading day on the SEHK or if the SEHK opens for normal trading only in the afternoon, or 12:55 p.m. (Hong Kong time) if the SEHK opens for normal trading only in the morning of the relevant Dealing Day. "
