For example, under HKIDR, starting from the next Hong Kong trading day after my consent withdrawal, I am only eligible to sell, transfer out or withdraw my existing holdings of local securities (if any). If there is any outstanding buy order on local securities, it will be cancelled. When FINI is effective, I cannot subscribe for IPO after my consent withdrawal, but IPO subscription application which has been submitted before the consent withdrawal will not be impacted nor automatically cancelled. I need to cancel it separately by myself (if it is cancellable) in case I do not wish to proceed with such application. I accept the consequences of such withdrawal.

Once SEHK accept the registration, the Customer will be eligible to services in relation to securities listed or traded on SEHK starting next Hong Kong trading day. If SEHK reject the registration, all the Customer's outstanding local securities buy orders pending for processing on next Hong Kong trading day will be automatically cancelled.
