

Terms and Conditions of Hang Seng "Thai Amazing Pay" Travel E-Cash Vouchers Lucky Draw

1. This "Thai Amazing Pay" Travel E-Cash Vouchers Lucky Draw Promotion (the "Promotion") is offered by Hang Seng Bank Limited (the "Bank") from 4 December 2023 to 4 March 2024 (both days inclusive) (the "Promotion Period").

Eligibility

2. The Promotion is applicable to personal customers who are holding any Savings/ Current Accounts in any currency maintained with the Bank in their sole name or in the capacity as the primary account holder in the case of a joint account and maintains a valid email address on the Bank's record ("Customer"). The Promotion is not applicable to Commercial Banking customers of the Bank.

Entitlement to the Basic Lucky Draw Entry by the "FPS x PromptPay QR payment"

3. Customer can entitle to one lucky draw chance ("Basic Lucky Draw Entry(ies)") after successfully settle any amount of merchant spending in Hong Kong Dollars (HKD) via HKD Savings/ Current Accounts maintained with the Bank in their sole name or in the capacity as the primary account holder in the case of a joint account ("Eligible Payment Account") via the "QR code pay/receive" service on Hang Seng Mobile App within Thailand ("Eligible Merchant Spending") during the Promotion Period. The aggregate number of the Basic Lucky Draw Entry(ies) a Customer can accumulate for completing the Eligible Merchant Spending is limited to a maximum of 10 Basic Lucky Draw Entries per Customer during the entire Promotion Period.

The Eligible Merchant Spending

- 4. The Eligible Merchant Spending is only applicable to the spending transactions at the merchants located in Thailand that accept payments via the "QR code pay/receive" service on Hang Seng Mobile App.
- 5. The Promotion is only applicable to the Customer(s) who make the Eligible Merchant Spending in HKD.

Entitlement to the Extra Lucky Draw Entry by conducting FX Transaction(s)

6. Customer can entitle to an extra one lucky draw chance ("Extra Lucky Draw Entry(ies)") after successfully complete a currency exchange of at least HKD5,000 or its equivalent, in a single FX transaction through personal integrated account (including Prestige Private, Prestige Banking, Preferred Banking and Integrated Account) with the Bank in their sole name or in the capacity as the primary account holder in the case of a joint account via the "Foreign Currency Exchange" service on Hang Seng Mobile App or Personal e-Banking(Desktop version) (the "Eligible FX Transaction(s)") during the Promotion Period. The aggregate number of the Extra Lucky Draw Entry(ies) a Customer can accumulate for completing the Eligible FX Transaction(s) is limited to a maximum of 10 Extra Lucky Draw Entries per Customer during the entire Promotion Period.

The Eligible FX Transaction(s)

- 7. To determine the transaction amount for any cross currency exchange, the relevant amount will be converted into Hong Kong Dollars based on the exchange rate solely determined by the Bank on the relevant transaction day.
- 8. For FX Order Watch transaction, the FX target limit order must be placed within the Promotion Period and successfully executed with currency conversion in order to be considered as the Eligible FX Transaction.
- 9. The followings will not qualify as the Eligible FX Transaction(s): Foreign exchange transaction(s) involving notes exchange, cash deposit, notes withdrawal, inward/outward remittance, Overseas Transfer Service, Passbook Savings Account, Virtual Assistant HARO services and foreign exchange transaction(s) made on pre-defined dates by way of forward dated instruction(s)

The Basic Lucky Draw Entry(ies) and Extra Lucky Draw Entry(ies)

- 10. The eligibility for an Extra Lucky Draw Entry by successfully completed an Eligible FX Transaction is limited to the Customer who has completed at least one Eligible Merchant Spending during the Promotion Period.
- 11. Basic Lucky Draw Entry(ies) and Extra Lucky Draw Entry(ies) respectively are collectively referred to as the "Total Lucky Draw Entry(ies)". Each customer can entitle to a maximum of 20 times in Total Lucky Draw Entry,



subject to a maximum of 10 times each in the Basic Lucky Draw Entry(ies) and the Extra Lucky Draw Entry(ies), during the Promotion Period.

The Lucky Draw Prizes

12. - 14. The Bank will determine the eligibility of the winners of the Travel E-Cash Voucher(s) based on the record of their Eligible Merchant Spending and Eligible FX Transaction(s) held by the Bank ("The Winner(s)"). In case of any disputes, the Bank's record shall be final and conclusive.
- 15. The Winner(s) must still hold the Eligible Payment Account and maintain valid email address in the Bank's record on 31 May 2024 in order to receive the Lucky Draw Prize.

Lucky Draw Winners Notification and Arrangement of Travel E-Cash Voucher(s) Redemption

16. Each Winner will receive a redemption email based on his/her email address in the Bank's record on or before 31 May 2024. The redemption email will contain the Travel E-Cash Voucher won in the Promotion in the form of a redemption code (the "Travel E-Cash Voucher Redemption Code"), and the terms and conditions of the redemption ("Hutchison Terms and Conditions").
