Terms and Conditions for the Priority Pass Associate Membership issued to Hang Seng UnionPay RMB Diamond Commercial Card Cardmember

- Successful applicant for Priority Pass Associate Membership ("Priority Pass Membership") will be offered a Priority Pass Membership with 12-month validity commencing from the Priority Pass card issue date, subject to Cause 6 below ("Validity Period"). For new successful applications of the Hang Seng UnionPay RMB Diamond Commercial Card ("Commercial Card") and the Priority Pass Membership, the Priority Pass card issue date shall be the same as the Commercial Card issue date.
- 2. Successful applicant may use the Priority Pass card to enjoy free access of the airport VIP lounges worldwide which are provided by Priority Pass (A.P.) Limited ("PP") during the Validity Period. For the latest information on the locations of the airport VIP lounges, please visit www.prioritypass.com.
- Successful applicant may bring guests to use the airport VIP lounges and Hang Seng Bank Limited ("Hang Seng")
 will charge a fixed sum of <u>CNY160 per guest per visit</u> from the Commercial Card account of the respective
 Authorised Card User.
- 4. If Authorised Card User uses the Priority Pass card to enjoy free access of the airport VIP lounges, the Cardmember and Authorised Card User are required to accept and agree to use the Commercial Card for spending of at least CNY5,000 within the Validity Period ("Spending Requirement"). If the Cardmember and Authorised Card User fail to meet the Spending Requirement, Hang Seng will charge a fixed amount of annual Administrative Fee, being CNY500, and such fee will be debited directly from the Commercial Card account upon the end of the Validity Period. For the avoidance of doubt, the Cardmember and Authorised Card User shall remain liable for the charges of all lounge visits made by guest(s) made prior to the date when the notification of the Priority Pass card being lost, damaged or stolen or request to cancel the Priority Pass card is actually received by Hang Seng. A charge of CNY100 will be levied for replacement card.
- 10. Hang Seng has no control over the opening times, facilities, service or personnel of the airport VIP lounges participating in Priority Pass Program. The said lounges are subject to the administrative procedures of the individual lounge owner/operators and may alter at any time without prior notification to Hang Seng. Hang Seng shall not be liable for any loss, consequential loss or damages suffered by the Authorised Card User and/or the accompanying guest(s) as a result of any alteration in any lounge owner/operator's administrative procedures or lounge facilities or opening times, or, for any wrongful, incomplete or inaccurate information relating to the Priority Pass Program given to the Authorised Card User and/or the accompanying guest(s) by any lounge owner/operator's employees or agents.
