

### **Application channel for Opening Personal Account**

- Use Hang Seng Mobile App (for people who aged 18 or above and residing in Hong Kong); or
- Visit any of our branches in Hong Kong (or through Witness account opening at designated branches in Mainland China)

## **Documents and Information Required**

Please prepare the **<u>original</u>** copy of the following documents and Mobile phone (require mobile telecommunication service to receive "One-Time Password" via SMS) for account application. The collection of the following document(s) and/or information enables us to understand each of the relationship that we build and is part of our due diligence process. In accordance with regulatory requirements and the HSBC Group policy, three types of document(s) and/or information may be required:

- Section I. Identification proof(s) for the purpose of verifying customer's identity
- Section II. Residential address proof for the purpose of verifying customer's address (if applicable)
- Section III. Others (e.g. employment information, purpose of account) for the purpose of having a fuller understanding of our customers

10	A Lawyer's confirmation of property purchase, or legal document recognizing title to property issued within the last 3 months	
11	A letter from a Hong Kong employer issued within the last 3 months together with proof of employment that confirms residence at a stated address in Hong Kong	
12	A current Hong Kong domestic helper employment contract stamped by an appropriate Consulate issued within the last 24 months and a copy of your visa within validity date	
13	For non-Hong Kong residents, a valid government-issued photographic driving license or national identity card containing the current residential address or bank statements issued by a bank	
14	An acknowledgement of receipt duly signed by you in response to a letter sent by our bank within the last 3 months to the address provided by you	
15	A record of a visit to the residential address by our bank officer within the last 3 months	

Remarks:

a) We accept a printout of item 1-6 electronic document (electronic statement / notification) stated above as the address proof. However, you are required to sign on the said document to declare that such printout is a true electronic copy.

- b) If your address proof is not in English or Chinese, a certified translation by a professional third party (e.g. lawyers, notaries, actuaries, CPA, persons or institutions who provide company secretarial service, consulates) should be provided.
- c) Address proof with a "c/o company address", "c/o personal address", commercial address or PO box is not acceptable.
- d) Address printed on envelopes is not acceptable.
- e) Personal account(s) should only be used for personal banking services only. If you have any commercial purpose, please contact our Hang Seng 24-hour Business Partner Direct hotline 2198 8000 / visit one of our Business Banking Centers to further understand business account opening procedures.

## **III.** Others

We may also ask you to provide the following information where appropriate:

- Employment information including occupation, employer/business and monthly salary
- If applicant is student: Proof of student status such as a letter from a Hong Kong university/college or student card
- Purpose of account
- Reasons for setting up account in Hong Kong
- Initial and ongoing sources of wealth and/or income
- Level of activity anticipated in terms of transaction amount and number of transactions
- Source and description of account opening fund
- Types of banking services to be used
- Jurisdiction of Residence (that is the place where the applicant is liable to taxation by reason of residence) and Taxpayer Identification Number or its Functional Equivalent (TIN)
- All residential address(es) held within 1 year

The above list may not be comprehensive and we may request you for other documents or information not contained in the list for account opening. We may also need to take a copy of your identification document and address proof if considered as appropriate. If you are not able to provide such document or information, your application may be delayed or rejected.
