- 2. To receive the complimentary Green Card Membership and Welcome Offers, Customers are required to download the App and after successfully applied for the Green Card membership at the Club Avenue Member Service Counter.
- 3. The App and the Welcome Offers are provided by Club Avenue and governed by its own terms and conditions and/or privacy policy, which is not under the control of or connected with Hang Seng Bank Limited ("The Bank"). The Bank does not collect, use, transfer or retain any of customer personal data for the said purpose. - 5. If the Member reaches the Qualified Spending of HKD60,000 during the aforesaid initial validity period of 90 days, the membership will be upgraded to next membership tier, i.e. Ruby Card Membership with a new validity period subsisting till the end of the following calendar year.
- 6. If Member cannot reach the minimum Qualified Spending of HKD60,000 during the aforesaid initial validity period of 90 days, the Green Card Membership under the Programme will be automatically extended for another 90 days.
