

Terms and Conditions for “Account Opening Offer for Designated Branch of Hang Seng Bank”

1. The promotion period of Account Opening Offer for Designated Branch of Hang Seng Bank (“Promotion”) is from 12 August 2026 to 31 August 2026 (both days inclusive) (“Promotion Period”).
2. The Promotion is applicable to the following designated branches (“Designated Branches”) of Hang Seng Bank Limited (“Hang Seng”):
