8. The Bank and the Merchant reserve the right to vary or terminate the Offers at any time and to amend these terms and conditions from time to time without prior notice. In case of any dispute, the decision of the Bank and the Merchant shall be final.

Terms & Conditions for Offers by CUHK Medical Centre

 - (ii) Customers shall present their physical Hang Seng Preferred / Prestige / Prestige Private ATM card or Hang Seng Prestige World MasterCard for verification upon arrival at CUHK Medical Centre for patient registration. 6. Payment by Hang Seng credit card is not required in order to enjoy the Offers.
7. Certain services provided under the Offers (e.g. services provided at CUHK Medical Centre 11/F Wellness Centre) are only available to persons aged 18 or above.
