

## **Terms and Conditions of “Hang Seng Travel+ Visa Signature Card Exclusive Offer – Expedia 6% +FUN Dollars on Hotel Booking Offer”**

1. “Hang Seng Travel+ Visa Signature Card Exclusive Offer - Expedia 6% +FUN Dollars Rewards on Hotel Booking Offer” (the “Offer”) is valid from 1 January 2026 to 30 June 2026, both dates inclusive (“Promotion Period”) and is divided into 2 phases.

The offer is NOT applicable to booking which are booked directly with the non-designated Expedia website (<https://www.expedia.com.hk>), Expedia App, Hotels.com website <https://zh.hotels.com/>) or Hotels.com App.  
 5. Bookings made online through the Designated Website on the following items shall not be considered as “Eligible Transaction”: (1) Flight + Hotel package; (2) Flight + Hotel + Car package; (3) Hotel bookings to be paid at the destination; (4) Car bookings; (5) Flight bookings; (6) non-Hong Kong Dollars hotel bookings; (7) “Things to do” bookings and (8) refunded bookings.  
 6. The Offers is non-transferable, non-cumulative, cannot be exchanged for cash or other products and cannot be used in conjunction with any other discount, promotions, discounted items and fixed price items (unless specified).  
 7. All products, services and information related to this Offer are directly sold and supplied to customers by the Merchant who is solely responsible for all related obligations and liabilities.
